- a. PhD in Informatics with Emphasis in Geospatial Informatics
 - Courses already created
 - Emphasis areas are recorded on the transcript but not the diploma
- b. Neural Engineering
 - MS in Electrical Engineering with Emphasis in Neural Engineering
 - MS in Computer Science with Emphasis in Neural Engineering
 - MS in Computer Engineering with Emphasis in Neural Engineering
 - None of these will interfere with Interdisciplinary Neuroscience Program, and in fact could feed into the INP PhD program
 - Programs need to have 36 hours (rather than 30 hours) to have an emphasis area
- c. MLIS in Library and Information Science with Emphasis in Health and Medical Librarianship
 - Reviving this program – it had been deactivated for a while
 - All courses already on the books, both in and outside of the department
 - Area of high need in the industry
