- c. Truman School: BA Communication and BA Sociology are adding accelerated MPA after a total of 5 years combined UG and GRAD work
 - Having a Masters in Public Affairs is a critical need as there is an increase in
 jobs but not yet an increase in qualifications. The object is to get ahead of
 this curve and graduate students who will have qualifications by the time
 the qualifications increase in the job market.
 - Students begin to take 15 credit hours of dual enrollment in their senior year, and these credits count for both their BA and their MPA. This makes getting the MPA economically feasible for the students.
 - 36 credit hours total for the MPA degree which includes 2 classes that are practical experience plus a capstone experience and 3 credit hours over the summer for internship.
- d. Graduate Certificate in School Librarianship
 - The state government used to certify school (K-12) librarians if they took a test and passed it. New requirements include an existing teaching certification, taking and passing the test, taking the 4 courses in the GC program.
 - The GC also serves as a means to funnel people into a master's program.
 - The GC program will have advisory board, who are already on advisory council for entire school, who are themselves school librarians.
 - This program is 100% online for all intents and purposes, and these courses are already existing and are just being bundled into a GC.
 - As flagship university, as the only university in the state with an American Library
 Association-accredited library program, we want to attract the students who want to
 start with GC and continue to Masters.
- e. MEd in Learning, Teaching, and Curriculum with social studies certification emphasis
 - Online pathways to certification with a field component (either in the school they already work in or through a placement system)
 - Masters level targeted for people who are already teaching under emergency certification and who want to get really certified
 - Do not have to have a certification to be eligible, but do need to have a degree in a content area of social studies (history, etc.)
 - Missouri continues to be in a teacher shortage so this is timely.

- b. Awards Marcello Mogetta, chair
 - Thank you for all committee members, all awardees were honored at April 24 award reception.
- c. Policy Prof. Chi-Ren Shyu, chair
 - i. Graduate Student Vacation Policy key point for this policy is that for all qualifying assistantship (GRA, GTA, Graduate Instructor, Graduae Fellow, and Graduate Library Assistant) we provide 10 working days vacation over 12 month appointment; prorated for 9 month appointment to 7.5 working days; students should work with supervisor if they need additional time.
 - ii. Because the students are part-time they get no benefits and are considered employees for unionization purposes only, but GTAs and GIs are technically eligible for unpaid FMLA, so we are creating a policy that doesn't exist currently except possibly on an NIH grant (which would supercede the college level policy).
 - iii. This basically puts everyone on equal footing as far as time off. This is dedicated vacation time, not Paid Time Off as we have it for full-time non-academic employees (which combines sick, vacation, and other types of time off).
 - iv. We don't have a sick policy for qualifying titles, so that's something that could be worked on in the next session of the Graduate Faculty Senate.
 - v. Agreed by consensus: text of policy should be amended to list out all 5 exact qualifying titles and amend if/when 6th qualifying title comes along.
 - vi. Effective date of this policy, if approved, could be 8/1/2024 to match the appointment start dates for Fall 2024.
 - vii. Motion to accept as amended by Beversdorf, seconded by Mogetta.
